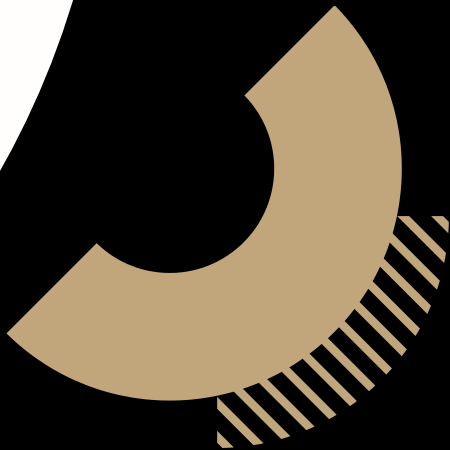

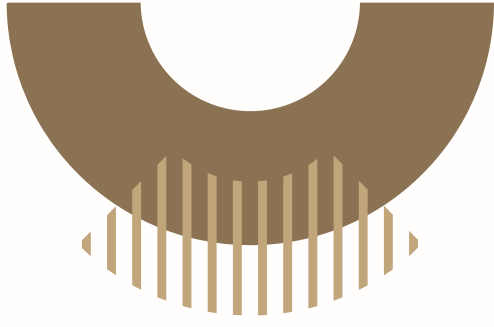

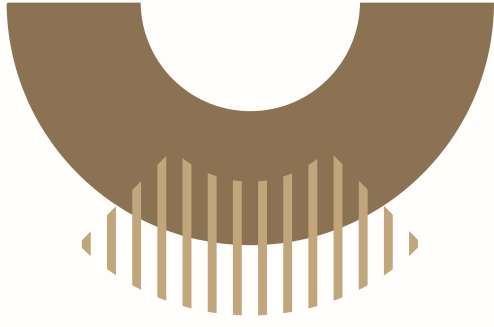
### Lawyer Khaled bin Nouh Al-Basit - General Manager

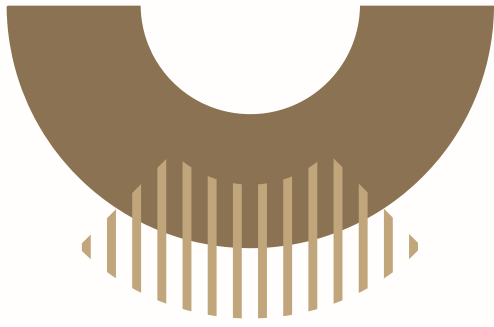
## Our Team
